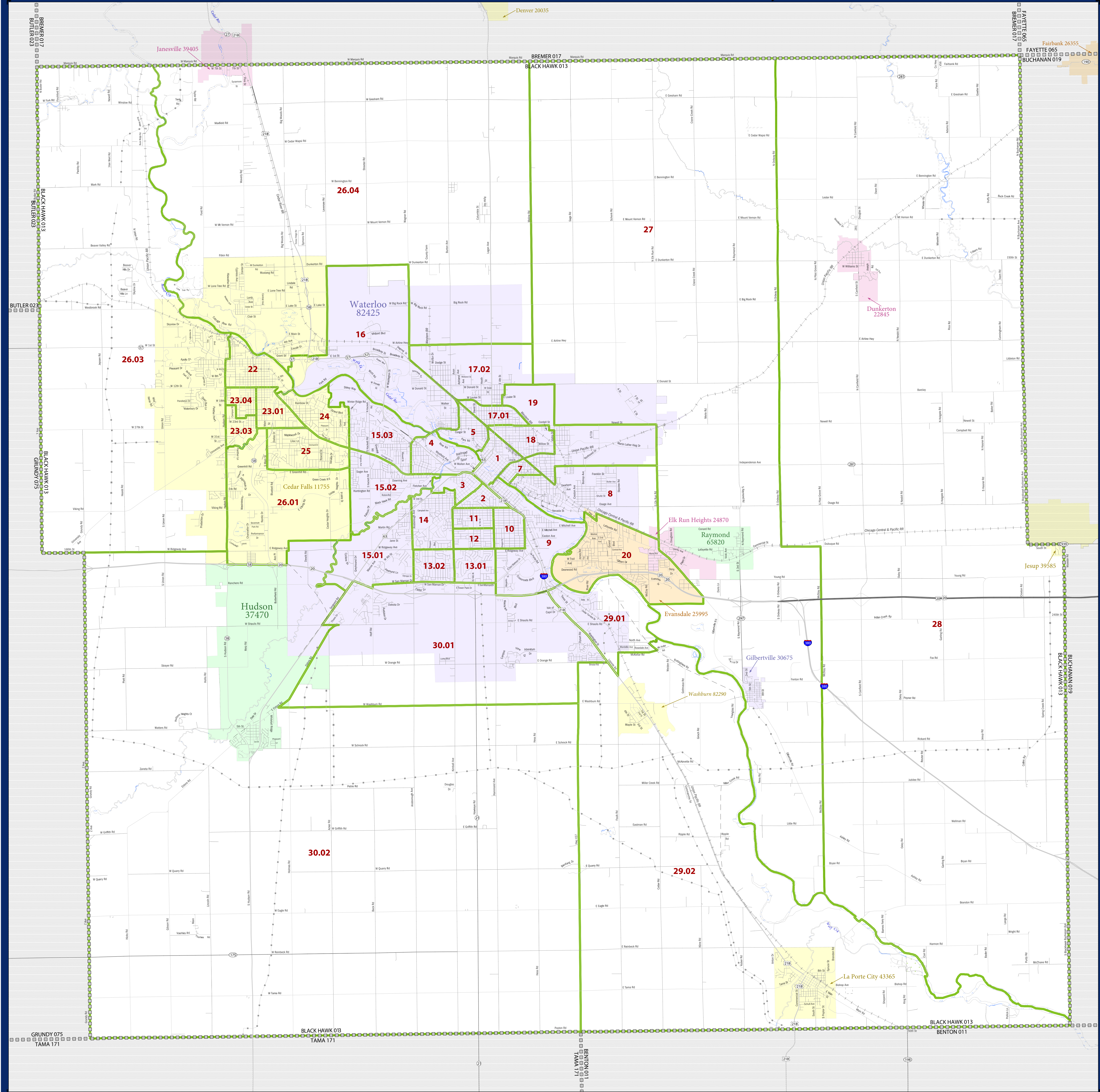


2010 CENSUS - CENSUS TRACT REFERENCE MAP: Black Hawk County, IA

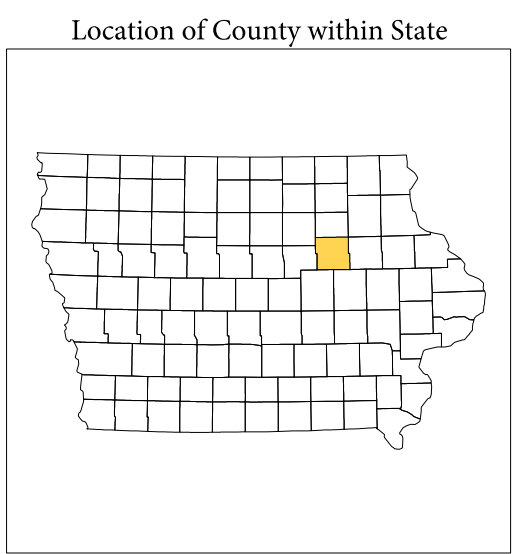

3 Place label color correlates to the place fill color.
