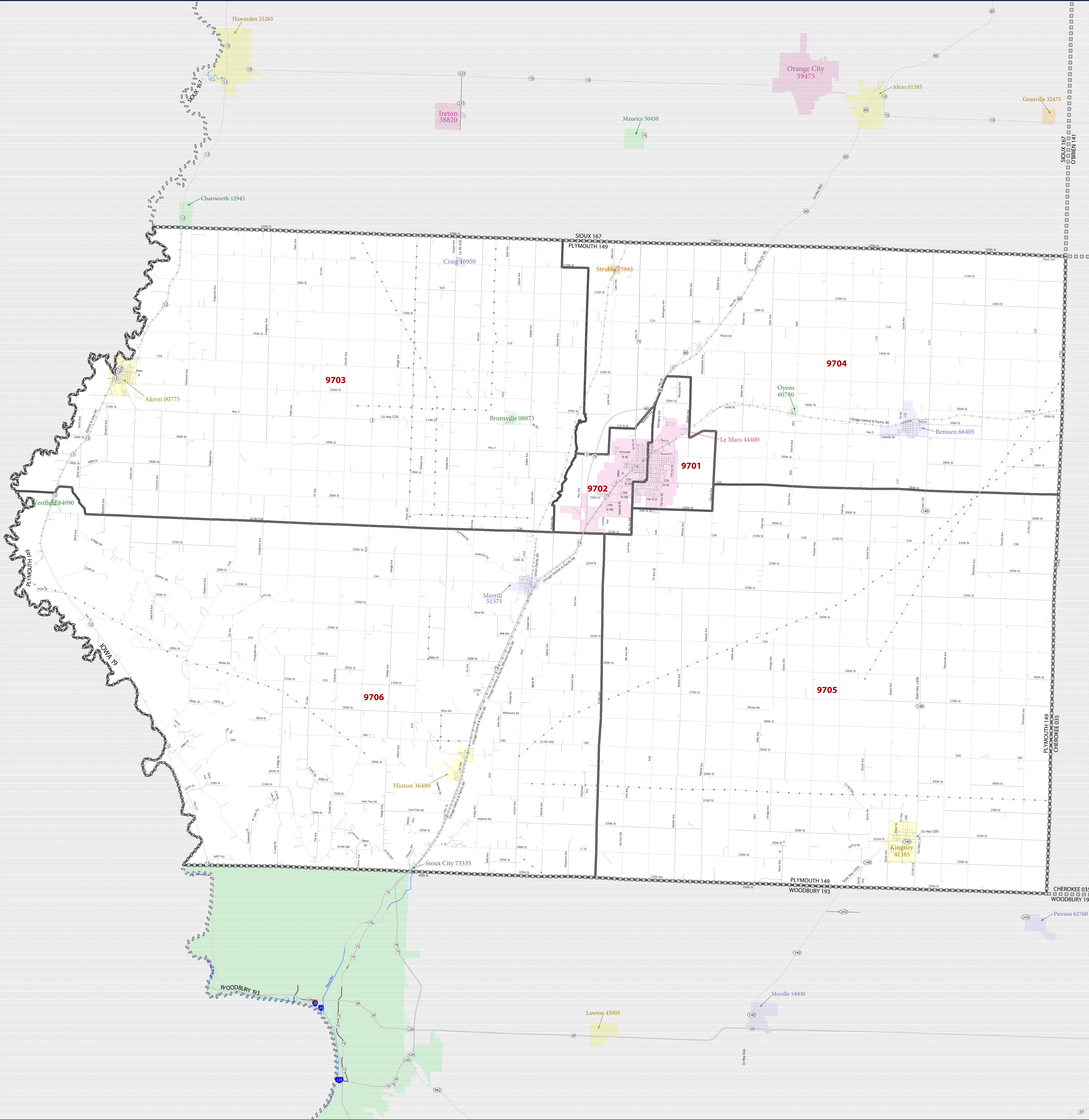


2010 CENSUS - CENSUS TRACT REFERENCE MAP: Plymouth County, IA



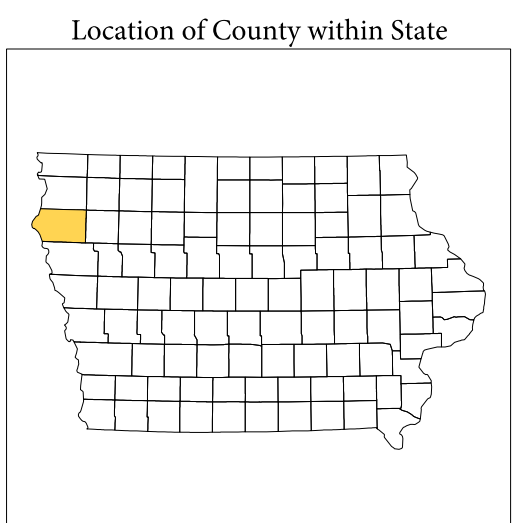

3 Place label color correlates to the place fill color.
